In consideration for the Participant's participation in a trip to Haiti sponsored by **Hope for Haiti, Inc.**, commencing in Port Au Prince on _____ (the "Trip"), the undersigned Participant, being 18 years of age or older and legally competent, for myself and my heirs, executors, administrators, and personal representatives hereby:

1. Acknowledges that I am voluntarily participating in the Trip, fully understand that travel to Haiti, a third-world country, involves the risk of injury, sickness, death, damage, and expense, even when accompanied by an employee or volunteer of **Hope for Haiti, Inc.**, and agrees to assume any risk involved with respect to myself, or others;

2. Understands that some dangers that I may face include but are not limited to: physical exertion for which I am not prepared; forces of nature; weather related problems; travel, whether in civilized or remote areas and by plane, train, auto, boat or other conveyance, or on bicycle, horseback, by foot, or other form of active or passive travel; consumption of food or of alcoholic or non-alcoholic beverages; civil unrest; terrorism; breakdown of equipment; high altitude; accident or illness without access to means of rapid evacuation or availability of medical supplies; or the adequacy of medical attention once provided;

3. Releases and forever discharges **Hope for Haiti, Inc.**, its affiliates and related parties, and their respective successors, directors, officers, managers, members, employees, volunteers, and agents (the "Releasees"), from any and all damages, attorney fees, expenses, liability, claims, or demands for personal injury, sickness, or death, as well as for property damage and expenses, of any nature whatsoever (including, but without limitation to, attorneys fees and expenses) (the "claims"), that may be incurred or suffered by me arising from or related to the Visit, including but not limited to the negligence of Hope for Haiti, Inc., its affiliates or related parties, or their respective successors, officers, owners, directors, employees, managers, volunteers, or agents;

4. Indemnifies and holds the Releasees harmless for all claims arising from or related to my own negligent, willful or intentional acts during the Trip; and

5. Acknowledges that I have carefully read and understand all matters covered by this Liability Release Form (this "Release"), WHICH PROVIDES FOR THE LEGALLY ENFORCEABLE WAIVER OF RIGHTS, and I sign this Release voluntarily.

This Release, which contains the entire agreement with respect to the foregoing matters, shall be governed by and construed in accordance with the laws of the State of Florida.
